## Hoan Bridge Crumbling

South Shore Mayors and I are responding to the latest stall tactic from the Wisconsin Department of Transportation (DOT) regarding the Hoan Bridge.

The DOT is seeking a contractor to “install netting underneath a portion of the Hoan Bridge near the Jones Island Water Reclamation Facility” as well as improve and repair existing netting near Summerfest. Reports indicate the DOT is installing the netting to catch falling chunks of concrete.

I am disappointed in the DOT’s failure to complete engineering studies to re-deck the Hoan, despite a promise from DOT Secretary Frank Busalacchi to do so. This is not the RFP we want to see from the DOT. We ask for an engineering study to include the Hoan Bridge in the next budget cycle. Any RFP should actually fix the Hoan, rather than delay it any further. The Hoan has served us well past its useful lifespan.

The Hoan Bridge is a critical conduit for commercial and residential traffic, connecting the Port of Milwaukee, General Mitchell International Airport, and the South Shore to the Marquette Interchange and the entire Interstate system.

The Coalition to Save the Hoan, a broad group of Wisconsin residents including community, business, and elected leaders, has held public hearings and advocated for the preservation of the Hoan Bridge. In November 2009, the Coalition submitted over 8,000 signatures to Governor Jim Doyle asking the State to re-deck the Hoan and abandon alternatives.

## Resolution on Contract Class Action Lawsuits

I have sponsored a resolution on class-action lawsuits brought by contractors against Milwaukee County. My resolution follows a federal law that bans contractors doing business with the government from using insider information gained during its representation to bring class-action lawsuits against the governmental body. It is common knowledge that class-action lawsuits bolster attorney fees exponentially.

On behalf of the taxpayers who elect County Supervisors to legislate, it is at least fair game to look at this matter. A troubling issue is created when the same contractor uses the judicial branch of government to legislate policy that the contractor seeks to create or enforce through class actions. Even when such policy is a good one, the electorate votes for County Supervisors to represent them in the policy arena, not contractors.

In representing juveniles and other vulnerable clients, the relationship assumed by the Legal Aid Society or any other legal service firm is not typical of a normal attorney/client relationship, where the client directs the attorney's actions. In these cases, the attorney often directs the client without any client oversight.

When considering that Legal Aid will be paid more than \$5.3 million by Milwaukee County over the next three years, yet could bring class-action lawsuits to direct policy, elected representatives might question whether this coziness within the system creates a conflict that should be avoided.

The resolution in question would not hamper the legal service firm from vigorously representing the client. Instead, it seeks to keep the forum neutral so it is ultimately fair. It is true that a chief judge appointed Legal Aid Society to represent prisoners in the Christenson Jail lawsuit. Yet if this resolution had been law at that time, any other law firm not contracting with the county could have been appointed. This would at least avoid the appearance of conflict.

## Airport Noise Update

General Mitchell International Airport is conducting another sound insulation program. The Airport will select homes based on proximity to the Airport; home type; home construction materials; schedule; and available funding. The Noise Abatement program will contact you if your household is included in this latest initiative against airplane sound.

## Arizona Measure

I have received many contacts from constituents regarding a proposed boycott against Arizona. I did not support this provision and will continue to vote against any further efforts to make this the policy of Milwaukee County. I find this issue to be outside the jurisdiction of Milwaukee County. I am concerned that workers and businesses would suffer repercussions of such a measure.

## Nutritious Meals for Seniors

Have you heard of the Senior Stockbox program, a great resource for senior citizens? This program provides boxes of canned food, juice, fresh meat, cheese, and much more to seniors in Milwaukee County at least 60 years of age that meet federal income requirements. Combined household income cannot exceed \$1,579 monthly to receive this benefit.
